

<p>P102: keep out of reach of children Non-hazardous Avoid eye- and skin contact Application takes place under adequate ventilation. Wash hands before breaks and after use.</p>	<p>General: Seek medical attention when symptoms occur, or in any case of doubt. Eye contact: Remove any contact lenses. Rinse and flush immediately with plenty of water at least for 10 minutes. If irritation persists, seek medical attention. Inhaled: Move person into fresh air. Seek medical attention when symptoms occur. Skin contact: Skin that has been in contact with the material should be washed careful with water and soap. Do not use solvents or thinner. Seek medical attention when symptoms occur. Swallowed: Do not induce vomiting. Give person plenty to drink and keep person under surveillance. If feeling unwell, seek medical advice.</p>
